2. An Expert Team conducted on-site evaluation of the programs during 17th to 19th April, 2015. The Report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The competent authority in NBA has approved the accreditation status to the following programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The above programmes have been granted provisional accreditation for 2 years. As such, BRCM College of Engineering & Technology, VPO – Bahal, Distt. Bhiwani – 127 028 Haryana should submit the Self-Assessment Report alongwith a Compliance Report at least after one year to be considered by the Engineering Evaluation and Accreditation Committee (EEAC) to formulate a view whether compliance report is enough to recommend for accreditation or a visit to the Institute is necessary. The recommendations of the EEAC will be considered by the Sub-Committee of Academic Advisory Committee of Engineering for a decision.

5. The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **BRCM College of Engineering & Technology, VPO – Bahal, Distt. Bhiwani – 127 028 Haryana as a whole. As such the Institute should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.** Complete name of the program(s) accredited, level of programs and the period of validity of accreditation, as well as the date from which the accreditation is effective, should be mentioned unambiguously whenever and wherever it is required to indicate the status of accreditation by NBA.

6. The accreditation status of the above programs is subject to change on periodic review, if needed by the NBA. It is desired that the relevant information in respect of accredited programs as indicated in the table in paragraph 2, appears on the website and information bulletin of your Institute.

7. The accreditation status awarded to the programs as indicated in table in paragraph 2 above is subject to maintenance of the current standards during the period of accreditation.
